MEMBERSHIP CATEGORIES



MEMBERSHIP CATEGORIES

EXECUTIVE MEMBERSHIP

Applies to one individual 19 years and older wanting to maximize use of the facilities on an annual basis. No restrictions on hours or number of rounds played per season. Annual full membership dues include:

- Unlimited play on two 18-hole championship courses
- 6 day advance booking privileges
- Zone 2 Membership - includes events, handicap services, preferred rates, BC Men's and Ladies Association Dues
- Unlimited use of driving range and grass short game practice facilities
- 15% off golf apparel and shoes
- Discounts on golf equipment and FREE custom club fitting
- Discounts on OGC Tournaments and member events
- GOLF CANADA handicap, record keeping and certification
- Discount on green fees for guests (up to 11 per day – max. 3 tee times)
- Discount on daily cart rental, includes guests
- Annual cart rental, club storage and locker rental available
- Private trackage, with or without storage, available
- Outside Service Program
- Full voting rights and eligible to hold any Club office (in good standing)
- Reciprocal rates at various golf clubs (see Pro Shop or Admin office for details)

One time Initiation Fee for Executive Member status is non-refundable and non-transferable. This is a non-equity membership.

An Executive Member who cannot play unlimited golf may apply to the Board of Directors or Membership Committee to pay a retaining fee rather than full Annual Dues. Playing privileges are not included in the retaining fee, so if the member wishes to play golf, the member must pay green fees or purchase a playing package. Fees required to convert back to unlimited playing status will be on a prorated basis.

ASSOCIATE MEMBERSHIPS:

Associate Members are Season Pass holders who do not pay an Initiation Fee, and therefore are not permitted to vote or to hold any OGC office. Play may be limited.

CORPORATE MEMBERSHIP

Defined as a membership purchased by a Corporation. Annual sponsorship of the OGC is inherent in the purchase of a Corporate Season Pass. Current Executive members may transfer to Corporate Membership, without any refund of Initiation Fees, and will be subject to all conditions of Corporate Members. Members are not eligible for private cart, trackage or storage. More information is available upon request.



INTERMEDIATE MEMBERSHIP

Designed for an individual between 19 and 39 years old wanting to maximize use of the facilities on an annual basis. Annual membership dues include:

- Playing privileges on two 18-hole championship courses
- Use of driving range and grass short game practice facilities
- 6 day advance booking privileges on either course
- Must pay Annual Dues as set by the Board
- The Pro Shop may restrict time and rounds played
- No voting rights or eligibility to hold Club office

There is no requirement to pay an Initiation Fee until the year of the member's 40th birthday. After the 40th birthday, the individual will either pay the Initiation Fee or purchase a playing pass or green fees. Upon payment of the Initiation Fee, the membership will become Executive.

JUNIOR MEMBERSHIP

Designed for an individual between 12 and 19 years old whose parent or guardian makes application in the prescribed form. The Pro Shop or Junior Coordinator must recommend acceptance. There is no requirement to pay an Initiation Fee. Annual membership dues include:

- Play on two 18-hole championship courses
- Use of driving range and grass short game practice facilities
- The Pro Shop may restrict time and rounds played
- Must hold a valid driver's license to operate power cart
- Must pay Annual Dues as set by the Board
- No voting rights or eligibility to hold OGC office

JUNIOR UNDER SUPERVISION MEMBERSHIP

Designed for an individual between 6 and 14 years old whose parents or guardians make application in the prescribed form. There is no requirement to pay an Initiation Fee. Based on age and assessed maturity the Pro Shop or Junior Coordinator will determine whether the member will play under supervision or as a Junior. The member must be accompanied by an adult golfer. A maximum of two Juniors under Supervision may play in a group. Annual membership dues include:

- Use of driving range and grass short game practice facilities
- The Pro Shop shall govern tee times and may restrict play
- Release form of liability to be signed by parent/guardian prior to approval of application
- No voting rights or eligibility to hold Club office

JUNIOR UNDER SUPERVISION - Seasonal

Designed for an individual between the ages of 6 and 14 whose parents or guardians make application in the prescribed form. Based on age and assessed maturity, the Pro Shop or Junior Coordinator will determine whether the member will play under supervision or as a Junior. The member must be accompanied by an adult golfer. A maximum of two Juniors under Supervision may play in a group. The Pro Shop may restrict time and play.

The member may be either a local or summer resident. The term of the membership will be from 1 July - 31 August. No Initiation Fee is required and the Seasonal Fee will be determined by the Board.



TEMPORARY RESIDENT / PGA MEMBER

Temporary residents must produce a company letter outlining the nature of their employment and the expected duration of residence in the Osoyoos region. PGA members must annually produce a current PGA membership card, validated as a member in good standing of their association. The Board may restrict the duration of this membership. Members are not eligible for private cart, trackage or storage. Annual membership dues include:

- 40 rounds per year – rounds in excess are charged at the guest rate
- 6 day advance booking privilege
- No Initiation Fee, voting rights or eligibility to hold Club office

STUDENT MEMBER

Designed for individuals aged 18 to 25 and enrolled in full time studies at a College, University or Technical School who wants to maximize use of the facilities on an annual basis. This member status assumes the individual will be restricted in their ability to play an ordinary amount of golf throughout the season. Membership includes:

- Playing privileges on two 18-hole championship courses
- Use of driving range and grass short game practice facilities
- 6 day advance booking privileges on either course
- Must pay Annual Dues as set by the Board
- The Pro Shop may restrict time and rounds played
- No voting rights or eligibility to hold Club office

This is non-refundable and non-transferable. This is a non-equity membership.

PLAYING PACKAGES:

RETAINER PLAY PACKAGE

Designed for an individual, 19 years and older, who has paid the Initiation Fee and wishes to retain Executive membership status. Annual membership dues include:

- Retaining Fee
- Maximum of 25 starts – no restrictions on the course or time of play
- All Executive Member benefits excluding unlimited golf
- Preferred green fee rate on any additional rounds

One time Initiation Fee for Executive Member status is non-refundable and non-transferable. This is a non-equity membership.
